IMPORTANT NOTES

- (1) The requirement to notify the Monitoring Officer of a disclosable pecuniary interest applies not only to your own interests but also those of your husband/wife/civil partner, or a person with whom you are living as husband/wife or as if you are civil partners, where you are aware that the other person has the interest.

The term 'relevant person' therefore means you and any other person referred to above.

- (2) Details of your notified interests will appear in the Members' Register of Interests and will be published on the Tonbridge and Malling Borough Council's website, and open to public inspection. Where your Parish Council has a website, details of your notified interests will also be published on that website.

I will be taking up employment in a Partnership with a friend running, initially, for four days. We will be running a pop-up Tea Room in the Mereworth Cricket Pavilion owned by Mereworth Parish Council. We will be renting the Pavilion from the Parish Council; of which I am a councillor.

Part B: Sponsorship

Any payment or provision of any other financial benefit (other than from Mereworth Parish Council) made or provided within the relevant period* in respect of any expenses incurred by you in carrying out duties as a member, or towards the election expenses of yourself. This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992

*'relevant period' means the period of 12 months ending with the day on which you give a notification for the purposes of section 30(1) or section 31(7), as the case may be, of the Localism Act 2011



Part C: Contracts

Any contract which is made between the relevant person (or a body in which the relevant person has a beneficial interest*) and Mereworth Parish Council—

- (a) under which goods or services are to be provided or works are to be executed; and
- (b) which has not been fully discharged

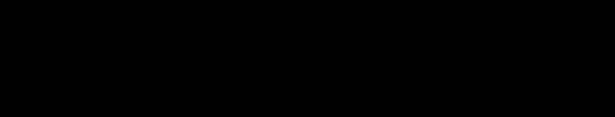
IMPORTANT

A member or co-opted member will commit a criminal offence if, without reasonable excuse, they fail to notify the monitoring officer of any disclosable pecuniary interests (DPIs). This requirement arises in each of the following circumstances:

- (a) before the end of 28 days beginning with the day on which you become a member or co-opted member of the authority (*s30(1) Localism Act 2011*);
- (b) where the DPI is not entered in the authority's register and is not the subject of a pending notification, but is disclosed at a meeting of the authority (or any committee, sub-committee, joint committee or joint sub-committee) as required by *s31(2)* of the Localism Act, within 28 days beginning with the date of the disclosure (*s31(3) Localism Act 2011*);
- (c) where the DPI is not entered in the authority's register and is not the subject of a pending notification, within 28 days beginning with the date when you become aware that you have a DPI in any matter to be dealt with, or being dealt with, by you acting alone in the course of discharging a function of the authority (*s31(7) Localism Act 2011*).

It is also a criminal offence to knowingly provide information that is false or misleading (or being reckless as to whether the information is true and not misleading)
